

## MOVEMENT RESTRICTIONS FOR POULTRY AND EVENTS

### **Fact Sheet**

The mission of the Kansas Department of Agriculture Division of Animal Health is to ensure the public health, safety and welfare of Kansas' citizens through prevention, control and eradication of infectious and contagious disease and conditions affecting the health of livestock and domestic animals in the State of Kansas

The Kansas Department of Agriculture Division of Animal Health has issued a stop movement order to protect the Kansas poultry industry and promote stronger biosecurity practices. With this, the comingling of poultry and live birds has been banned through December 2015 in effort to prevent the spread of H5N2 avian influenza (HPAI).

### STOP MOVEMENT ORDER

All events involving comingling of poultry and live birds have been effectively cancelled, including, but not limited to:

- Regional and county fairs
- Festivals
- Kansas State Fair
- Swap meets
- Exotic sales
- Live bird auctions

## H5N2 AVIAN INFLUENZA (HPAI)

Highly pathogenic avian influenza (HPAI) is a highly contagious viral disease to domestic poultry that can be easily spread through feces, saliva and respiratory secretions. Symptoms of HPAI include:

- Sudden increase in bird deaths in flock
- Sneezing, coughing, gasping for air, or nasal discharge
- Watery and green diarrhea
- Lack of energy and poor appetite
- Drop in egg production or change in shell thickness or shape

## **FREQUENTLY ASKED QUESTIONS**

#### What is included in the ban?

The order bans the comingling of poultry flocks at all poultry-related events, exhibitions and auctions through December, 31 2015. Such events include regional and county fairs, festivals, the Kansas State fair, swap meets, exotic sales and live bird auctions.

#### Can I still sell through private treaty off my farm?

Yes, as long as you sell the birds from of your property and do not bring them to a sale where they are in contact with another flock.

#### If I have eggs hatching can I sell the chicks?

Yes, you may sell them as long as they are sold without comingling with other birds.

# Can our local co-op or farm store continue to sell retail chicks?

Yes, since the birds are already together, they are considered a single flock and may continue to be sold.

#### How does this affect interstate travel?

If a Kansas bird is entering another state, you will need to call the state of destination to determine their import requirements. If a bird is coming into Kansas, the Kansas import requirements will need to be followed. Kansas import requirements have not changed and can be found online at:
