### **2026 Program Development Committee Elections**

Watch for the ballot being emailed later this month.

The Thomas County Extension Council is responsible for conducting the Extension Program in Thomas County. Each year we elect new members to the Program Development Committees. It is these committees that design the Extension program for Thomas County.

Each Program Development Committee (PDC) consists of six members who serve a two year term. New members from each PDC are elected each year. The entire Extension Council is comprised of 24 members with six members represented from each of the Agriculture, Family and Consumer Sciences, 4-H and Youth, and Community Vitality committees.

A ballot will be sent by email, but if more ballots are needed for members in your household, ballots will be available at the Extension office. After marking your ballot, please return it to the Extension Office by mail, by email, or by hand delivery. Ballots will not be accepted after 5:00 p.m. on Monday, November 3rd, 2025.

The results of our election will be announced at our annual meeting on Friday, November 14, 2025. At this meeting, the Council shall elect from its own members, nine people to serve on the Executive Board, which consists of a Chairman, Vice-Chairman, Secretary, Treasurer and five other members. The Executive Board has the responsibility for the entire Extension Program in Agriculture, Family and Consumer Sciences, 4-H & Youth and Community Vitality.

The problems and needs of people and their communities are in a constant state of change. Extension programs should reflect these changes. It is important, therefore, that the County Extension programs be given careful and continuous attention, so please take time to vote! All Thomas County citizens in your household, 18 years of age and older, are eligible to vote.

## Knowing What's in Every Bite: Understanding CRP Forage Quality


If I asked 10 different producers this question: "How good of quality do you think is your CRP (Conservation Reserve Program) forage for grazing?", I would expect that 9 would respond with something to the extent of "Not much better than trees!" or "About like corn stalks after harvest!". Maybe the other 1 person would say something like "Don't waste your time!". The reason for the proposed question is because that is exactly what KSU Extension Agents and Beef Specialists across the state have been working on to better understand recently.

While we typically think about pasture forage quality in the context of native grasslands, CRP lands represent a significant source of forage for producers in some areas. For us in Kansas, CRP lands in 2024 comprised over 12% of the state's total native grasslands. Back to the question of forage quality, it is a forage resource where available data to help guide producers is quite scarce. Certainly, emergency grazing or having of CRP during drought is the most common reason these forages are utilized, but there may be many other situations that lead to usage by producers. Information on standing forage quality is necessary for accurate feeding recommendations for producers, and it also applies to situations in which CRP tracts are harvested as hay. Yes, calf prices are at record high levels but our goal should still be to optimize our supplement inputs by avoiding both over- and under-supplementation. Having accurate forage quality estimates is key in helping us do so.


To improve our understanding of seasonal nutrient content changes of CRP forages across Kansas, a statewide assessment was recently conducted. Project details and preliminary data may be found in the 2025 KSU Cattlemen's Day Report (Schwartz et al., 2025; https://doi.org/10.4148/2378-5977.8660). In short, all standing forage above 1 inch was collected, so prior management impacted the sample quality. Some

samples would contain the current and prior year growth. Be sure to check out the 2026 Cattlemen's Day Report when available next spring which will contain the final summary of this project as a snapshot of those data are presented here.

In general, crude protein increased during the growing season and decreased during fall and winter for both eastern and western Kansas samples. For eastern Kansas samples, crude protein (% dry matter basis) ranged from less than 3% in February to over 6% in June, but some samples were as high as nearly 10% during that month (Figure 1).



On average, eastern Kansas samples were 4% crude protein in October and declined going into winter. Samples collected from western Kansas ranged from 3% crude protein in February to over 6% in June with wide ranges noted during the primary growing season months (Figure 2).



The key takeaway here is that these data have been generated to help serve as a benchmark guide for making informed nutrition decisions when CRP forages are used. There are certainly times when beef cow nutrient requirements may be met by CRP forages alone and times when supplementation will be needed. Keep in mind the following points: 1) variation in forage nutrient concentration exists 2) production stage of the cowherd will determine how well CRP forages meet requirements and 3) operation specific forage sampling can always help fine-tune nutrient intake estimates, but these data are a useful point of reference in getting started.

# Knowing a little science can help with making holiday candy

When it comes to making holiday candy, K-State Research and Extension food scientist Karen Blakeslee says it's a cooking process that usually turns into a food science experiment.

"Candy is basically divided into two categories: crystalline or non-crystalline," Blakeslee said.

Fudge is an example of a crystalline candy that requires special attention during the cooking process.

"You have to be careful when making fudge because sometimes you get little crystals that form inside and gives a grainy feeling in your mouth," Blakeslee said, adding that some crystals are acceptable, but "the goal is to limit the size of crystals that form when you're making fudge" or other crystalline candies.

"The size of the crystals should be very small to reduce the chance of a grainy texture," she said, adding that creams and fondant are additional examples of crystalline candies. They should be smooth, creamy, and easy to chew.

Fudge, she said, "is basically chocolate, corn syrup, butter and sugar, and maybe vanilla or other flavoring such as peppermint." For a quality end-product, Blakeslee said butter is key; don't use margarine or another substitute.

"Butter is important because the fat in cream helps prevent crystals from forming when making fudge," Blakeslee said.

Corn syrup can also help to prevent crystals from forming in fudge, she notes.

"If water gets into the product during the cooking process, crystals can form, so it becomes a balance between controlling the heat – how long you cook it – and watching for any kind of excess moisture," Blakeslee said. "Even humidity in the air can be absorbed into a candy and cause

problems. It really is a science experiment every time you make this type of candy."

In non-crystalline candies – toffee and peanut brittle are two examples – Blakeslee said you don't want any crystals to form, not even small ones. Other examples include lollipops, caramels, and nougats.

"For this type of candy, the sugar mixture is cooked to higher temperatures, such as the hard crack stage," Blakeslee said. "During cooking, moisture evaporates and the temperature rises higher than the boiling point of water. Reduced moisture content and rapid cooling are key factors in making non-crystalline candy."

According to Blakeslee, when making these types of candy, limit stirring to help reduce the formation of crystals.

Some cooks choose to add baking soda to brittle, which Blakeslee says lowers the acidity and makes the candy more brittle, or more porous: "It's easier to break and easier to bite and chew," Blakeslee said.

Blakeslee is also coordinator of <u>K-State's Rapid</u> Response Center for Food Science, which offers many more tips on food safety for the holidays online.

Blakeslee spoke recently about considerations for holiday candy-making on the weekly podcast, <u>Sound Living</u>, <u>available online from K-State Research and Extension</u>.







### New 4-H Year Begins in October

October marks the beginning of the new 4-H year and the opening of member enrollment. Where can youth and parents start if they are interested in enrolling in 4-H and want to learn more about what 4-H has to offer? #### What is 4-H?

4-H is one of America's oldest and largest youth development organizations. It is a volunteer-led, informal education program administered through local county extension offices, state land-grant universities and the USDA. It features nearly 6 million members, rural, suburban, AND urban, throughout all 50 states and some foreign countries.

#### What does 4-H offer?

- Leadership opportunities for youth at the local and state level.
- Recognition for work and achievement through fairs, scholarships, awards, and more.
- Opportunity to participate in county, regional, state, and national events, including camps, educational programing, leadership positions, and conferences.

# What makes 4-H different from other youth development organizations?

- **Self-determination** Youth decide what projects they want to participate in, as well as how their clubs operate and support members and the community they live in. 4-H is the only youth development organization where members actually decide how it operates.
- Experiential learning Members actively participate in their interest areas. Want to learn about insects? Start a bug collection in the entomology project. Like to work with your

hands? Build a rocket in rocketry or a table in woodworking projects. Learn to bake your favorite pie in foods and nutrition project. Interested in something that isn't an official project? No problem! Enter the Self-Determined project and come up with your own unique creation.

 Research-based support from local, state and national experts — 4-H is administered in Kansas through K-State Research and Extension, giving 4-H members, volunteers, and leaders access to the latest data in research and youth development.

#### Why 4-H?

A better question might be "Why not 4-H?"

A recent study of 4-H members across Kansas showed some positive results in areas of decision making, leadership, communication, and citizenship.

- 95% are comfortable making their own decisions
- 89% don't succumb to peer pressure
- 96% reported they can make a difference through community service
- 95% reported an increased effort to allow everyone to have a voice.
